<p>1. What changes in behavior, actions, policies or practices have you observed related to SIA implementation during the 2021-22 school year? How do you see these changes contributing to the goals and outcomes in your SIA plan? <i>(500 words or less)</i></p>	<p>Last year we supported our ELA teacher in receiving her dual credit teaching credentials so we are now able to provide a Math and an ELA dual credit class to our High School students.</p> <p>The school has added contracts with IXL as well as STAR Renaissance in order to provide more individualized learning plans for all of our students. STAR allows for a school wide assessment program we can use consistently across grade bands. IXL will then give us the opportunity to provide individualized activities for student learning in ELA and Math.</p> <p>Another area that we have provided is SEL by adopting a universal curriculum and having the counselor facilitate these activities everyday with individual classes.</p>
<p>2. What barriers or challenges to SIA implementation have you experienced that are helpful for your community and/or state leaders to be aware of? What adjustments, if any, did you make to your SIA plan as a result of these challenges? <i>(500 words or less)</i></p>	<p>Currently staffing is our number one problem. We have great teaching opportunities which would greatly help out our students by providing more PE and elective opportunities, but staffing is making this difficult.</p>

I am a new Superintendent and we have a newly added Assistant Principal. The communication with the community had not been as strong as it should have been after the change of administration. Therefore, this year we are working on bridging that gap by adding in a few more community engagement opportunities, creating a needed site council and opening up a before school opportunity to support parent schedules.</p>

<p>4. As you think about what guided your choices and prioritization efforts in this year of SIA implementation, what stands out? How will what you've learned this year impact future SIA implementation efforts? (500 words or less)</p>	<p>Based on what the prior team prioritized for their highest needs areas, it appears that mental health supports was brought up most in the planning process. Since coming in new this year, I have found that even with the extra focus and funding for mental health supports, it does not seem to be working for the school. Based on my observations and analysis of the year thus far, I think we need to start focusing more on supporting parental knowledge of best practices. This is not to say educators should insinuate a specific parenting style, but rather educate them on specific areas such as attendance, developmental stages and the specifics of educational standards. I believe that by supporting families more with the knowledge of how impactful their child's education is to not only their success, but also to their mental health, we will see more collaboration both in the schools and at home.</p>
